6.	Background of the Assignment	The National Disaster Management Authority (NDMA) is the apex-level institution for disaster management in India. The Disaster Management Act, 2005 provides for setting up the NDMA along with a host of other institutions at the national, state, and district levels. Chaired by the Prime Minister, the NDMA is mandated to lay down the policies, plans and guidelines for disaster management, and implement various programmes related to various aspects of disaster management. Since its inception, the NDMA has taken several initiatives and programmes in strengthening disaster preparedness and mitigation, improving disaster response and recovery, and supporting capacity-building activities in the country. The Sendai Framework for Disaster Risk Reduction (SFDRR) adopted at the 3rd UN World Conference on disaster risk reduction in Sendai, Japan on March 18, 2015 outlines seven clear targets and four priorities for action to prevent new and reduce existing disaster risks. It aims to achieve the substantial reduction of disaster risk and losses in lives, livelihoods, and health and in the economic, physical, social, cultural, and environmental assets of persons, businesses, communities, and countries over a period of fifteen years. The four priorities under the framework are 1. Understanding disaster risk Priority 2. Strengthening disaster risk governance to manage disaster risk Priority 3. Investing in disaster risk reduction for resilience Priority 4. Enhancing disaster preparedness for effective response and to "Build Back Better" in recovery, rehabilitation and reconstruction.

India as a signatory of the Sendai framework. NDMA has aligned the National Disaster Management Plan to Sendai framework. At the national level, the NDMA monitors the progress of implementation of the SFDRR and submits reports to UNDRR. NDMA coordinates with different ministries and department to collect data and information for preparing various mandatory reports.

Considering the importance of monitoring progress and periodical reporting on the progress made towards the SFDRR targets against different priorities in the country, the NDMA requires the services of an experienced professional as Senior Consultant Sendai Framework (Monitoring & Reporting).

- Coordinate & Collate data, prepare reports as per prescribed formats and obtain approvals from the competent authority for submission of data.
- Feed data into the online VC platform and also update wherever required at prescribed intervals.
- Organize training of staff from relevant stakeholders in data collections and compilation.
- Support NDMA for preparation & participation in the Global Platform for DRR particularly related to providing relevant data and information.
- Support NDMA for preparation and participation in the Asian Ministerial Conference on DRR particularly related to providing relevant data and information.
- Support NDMA in deciding program and project indicators aligned to the Sendai Framework.
- Prepare annual disaster reports and disseminate to key internal and external stakeholders.
- Participate in the meeting of NDMA Task Forces, Working Groups and Committees to provide technical inputs related to data collection, collation, disaggregation and development of indicators.
