2.0 QUALIFICATION & EXPERIENCE

For Sl.No.1: MBBS with MD/DNB in Medicine with minimum 4 years experience.

For S1.No.2: MBBS with MS/DNB/Diploma in Orthopedics with minimum 4 years experience.

For Sl.No.3: MBBS with MS/DNB/Diploma in ENT with minimum 4 years experience.

For Sl.No.4: MBBS with MD/DNB/Diploma in Radiology with minimum 12 years experience.

3.0 Reservation for SC/ST/OBC (NCL)/EWS/Ex-Servicemen/PwBD will be as per Govt. of India guidelines. PwBD means a person suffering not less than 40% (forty Percent) of disability as certified by Medical Board/Competent Authority duly constituted by Central or State Govt. The SC/ST/OBC (NCL)/EWS/PwBD certificate should be as per the format prescribed by Govt. of India. If the certificate has been issued in a language other than English/Hindi, the candidate will be required to submit a self-certified translated copy of the same either in English or Hindi, at the time of interview.

- **4.0** Upper age limit is relaxable upto 5 years for SCs/STs and 3 years for OBCs (Non-Creamy Layer) and as per Govt. guidelines for PwBD's/Ex-Servicemen.
- **5.0 EMOLUMENTS:** Apart from Pay and Allowances other benefits viz. PRP, Leave Encashment, CPF, Gratuity, Pension, Free Medical facilities, Group Insurance, Incentive, Residential Accommodation, Subsidized Electricity etc., as per rules will also be admissible. In addition, Non Practicing allowance (NPA) @ 25% of Basic Pay is payable for candidates possessing Post Graduate Degree and @22.5% for MBBS Degree with Diploma/PG Diploma.

6.0 General Conditions:-

- a) Experience and Age relaxation and higher start in the time scale may be considered in case of deserving candidates. Candidates may be considered for a lower post in case they are found otherwise suitable depending on their qualification, experience, present position and performance in the interview.
- b) To and Fro Single Second AC II tier Rail Fare by shortest route will be reimbursed to outstation candidates fulfilling the above requirements on production of tickets/photocopies of tickets. Interested candidates meeting the above requirements may **Walk-In for an Interview** along with their original certificates and detailed bio-data accompanied by self attested copies of certificates and testimonials and 2 recent colour passport size photographs, **on any one place out of the following three places from 9.30AM onwards on the scheduled dates.**
