Only those candidates who are willing to travel extensively and relocate to the places mentioned above may apply.

Relaxations: 3% of the posts will be reserved for Persons with Disability (PwBD). The upper age limit will be relaxable for SC, ST candidates by 5 years and for OBC candidates by 3 years. For candidates belonging to PwBD category having minimum 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

Terms of Engagement& Remuneration:

Project Engineer-I will be engaged initially for a period of 3 years which may be extended upto a maximum of one year based on project requirement and individual performance.

<u>Qualification:</u> Fulltime BE/B.Tech from a recognized University/Institution in the following disciplines —Electronics/Electronics & Communication/ E&T/ Communication/ Telecommunication, Mechanical. 55% and above aggregate marks in all semesters in the indicated qualification for General, OBC and EWS candidates and Pass Class for SC, ST and PwBD candidates. **Method of conversion of CGPA to percentage as per University norms should be compulsorily attached**.

<u>Post qualification Experience</u> (as on 01.08.2022): Candidates should have minimum of <u>2 years</u> of relevant post qualification industry experience to apply for the post.

Electronics: Experience in RF circuits, Microwave Receivers, High voltage transmitters and signal processing systems. Work experience in testing and maintenance of Radars and Communication Systems will be an added advantage.

Mechanical: Experience in maintenance of TATRA/Tata or any Special Vehicles, Trailers, Hydraulic and Pneumatic systems, cranes, DG Sets, Electromechanical systems such as Jacks and Masts, Air Conditioners, chiller plants, etc. will be highly desirable.

Note: Teaching experience, IT experience, experience in banking and financial institutions, non-profit organizations and, internship placements which are a part of academic curriculum will not be considered as experience. Work experience prior to completion of BE/B.Tech. will also not qualify as post qualification experience.

Candidates who are already working as Project Engineers in Bharat Electronics Limited are not eligible to apply.

SELECTION PROCEDURE:

• Selection will be through a Written Test followed by an Interview for shortlisted candidates.

- iv) Formula for CGPA conversion of marks obtained in BE/B.Tech as notified by the Institute/University.
- v) Caste /Tribe/ Community/ Disability/Economic status certificate in case of candidates belonging to SC/ST/OBC/PwBD/EWS respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format. The formats of various

certificates are provided as link to the advertisement. Candidates belonging to OBC category should produce the certificate issued on or after 01.08.2021.

- vi) Post qualification work experience certificate/s from previous / current employer. Where current employment certificate is not produced, the Offer of current appointment, Employee ID proof and latest pay slip mentioning the date of joining should be compulsorily enclosed.
- vii) A brief write up on the roles and responsibilities held in previous organization/s.
- $viii) \ Candidates \ working \ in \ PSUs \ / \ Govt. \ organizations \ should \ compulsorily \ submit \ the \ application \ through \ proper \ channel \ or \ produce \ 'No \ Objection \ Certificate' \ at \ the \ time \ of \ the \ interview.$
- ix) SBI Fee payment receipt.

- The application fee should be remitted through SBI Collect (through online mode or through SBI Branch).
- Candidates are requested to read the details and screenshots for making the payment.
- Candidates can also make the payment by approaching SBI branch. You have to select SBI branch in the payment option and download pre-printed challan generated through SBI Collect and deposit the application fee (as applicable) plus applicable bank charges in any SBI Branch. The candidate should ensure to obtain the seal and signature of the bank official.
- Candidates have to enter the "SBI Collect reference No." generated after payment, in the Application Form.
- Candidates may go through all instructions and eligibility criteria carefully before remitting Application Fee and submitting the application. Fee once paid will not be refunded.

GENERAL:

- Selected candidates are required to be covered under a medical insurance scheme for a sum
 of Rs.2 lakhs per annum and Life insurance for Rs. 5 lakhs per annum and submit the same
 on joining. In addition to the remuneration indicated, a consolidated amount of Rs. 12,000/per year will be paid towards expenses like medical insurance premium, attire allowance,
 stitching charges, footwear allowance, etc.
- Selected candidates will have to make their own arrangements for stay at posting location and the cost towards housing accommodation will not be borne by the Company.
