- Age:** The age of the candidates should be between 18 to 25 years as on the day of application i.e. on 08-02-2023. A relaxation in upper age limit is admissible as per the Govt. of India guidelines for SC/ST/OBC/PH

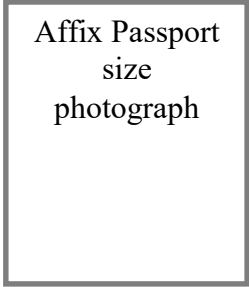
