

1. JAP-IT द्वारा 100/— रू0 प्रति आवेदन Charge किया जायेगा।
2. प्रति आवेदक 1000/— रू0 आवेदन शुल्क JAP-IT के Gate Way के माध्यम से JAP-IT के खाते में जमा किया जाएगा।
3. आवेदन प्राप्ति के उपरांत JAP-IT प्रति आवेदक 100/— रू0 काट कर शेष राशि राज्य आयुष समिति, आयुष निदेशालय, राँची को उपलब्ध कराएगी।
