General Instructions and Conditions:

- 1. Applications not in the prescribed format will not be processed or accepted (Annexure 1)
- 2. Incomplete application and application which are not in format prescribed and those not satisfying essential criteria will be summarily rejected without assigning any reason thereof.
- 3. No TA/DA will be provided for the candidates for attending the selection test.
- 4. The candidate will be selected **based on the merit in selection test**. The selection test will include interview and written test (depending on the number of candidates applied).
- 5. The above post is purely on temporary/contractual basis and the candidate will have no right to claim for permanent employment in the Institute/ under ICMR or continuation of his or her service in any other project and no claim for any other regular post in JIPMER shall be entertained.
- 6. No benefit of provident fund, leave travel concession, medical claim, etc. will be considered.
- 7. Canvassing of any kind will lead to disqualification. Submission of wrong of false information during/after the process of selection shall disqualify the candidature at any stage and will lead to necessary action.
- 8. The total duration of the project is 3 years. However, the duration of requirement of manpower is 2 years 9 months only. The first initial contract appointment will be given for a duration of one year only. The contract appointment will be extended for further period of one year nine months depending on the candidate's performance and budget grant from the funding agency. If

performance of the appointee is not found satisfactory by the investigator, appointment can be terminated at any time without any notice. The contract period is co-terminus with the project

- 9. Validity of the selected list is valid for 14 months from the date of publication of results.
- 10. The appointee may be relieved from the current job position if he/she wishes, with one month prior notice. Relieving earlier may require a deposit of paying one month stipend.
- 11. Only eligible candidates based on the evaluation of application and certificates will be shortlisted and considered for further selection process.
- 12. Selected candidates shall submit all original documents for verification on the date of joining failing which the selection will be cancelled.
- 13. The core responsibilities include implementation of study procedures, co-ordination of activities and any other relevant work assigned by the PI.
- 14. Annual/Accrued leave: 30days per annum (Pro-rated @2.5days per month of completed service). On termination of the contract, you will not be entitled to carry forward of leave or to the benefit of encashment of earned leave.
- 15. The decision of the Competent Authority will be final and binding.
