In reference to the recruitment notice memo no.DH&FWS/1471 dt.06.07.2022, "Priyal Sarkar, C/o. Pijush Sarkar, Vill- Mahi Nagar, PO-Beltola Park, PS- Balurghat, D.Dinajpur -733103" is hereby engaged on contract basis for the position of "Staff Nurse" in Polyclinic under XV-Finance Commission -Health Grant. He will be posted at "English Bazar UPHC-3, Ward No.23, SM Pally, GK Sarani, Station Road, English Bazar Municipality, Malda" and will get a consolidated monthly remuneration of Rs.25,000.00 (Rupees Twenty Five Thousand) from concerned activity head of XV-Finance Commission -Health Grant.

The candidate is hereby engaged as per the terms and conditions mention below:

- The engagement is subject to the final outcome of the petition filed WPA (P) 335 of 2022 Pijus Patra Vs. The State of West Bengal
- The engagement is made purely on contract basis till 2025-2026 i.e.it will be co-terminus with the tenure of XV-Finance Commission Health Grant.
- 3. However, the contract period will be renewed every year based on satisfactorily performance of the Candidate.
- There will be no enhancement of remuneration during the tenure of his /her contract period.
- No transfer request will be entertained during the engagement period.
- This engagement will take effect from the date he/she joins the position.
- 7. The service may also be terminated by one month's notice from either side.
- If the incumbent proposes to give up his/her work without covering 1 (one) month's notice period, his/her remuneration will be deducted accordingly.
- The Candidate has to produce a Medical Fitness Certificate from the registered Medical Practitioner (Medical Council/Homoeopathy Medical Council / Ayurvedic Medical Council or Unani Council) in the enclosed format and a valid photo identity proof of himself/herself at the time of joining the position.

- 11. The candidate should join within 07 (Seven) days from the date of issuance of the order. If 7th day is a Govt. holiday then the candidate may join on the next working day.
